

- -Hawaii Capital Holdings, LLC is the sole General Partner, with 1% equity/capital interest in the licensee and full and exclusive right to control, manage, and operate the licensee business, provided that certain major corporate decisions and actions (such as transfer of partnership interests, sale of substantially all assets, dissolution of the business) require the consent or approval of the Limited Partner, as is typical in limited partnership agreements. CS Wilton Group LLC remains the sole member of Hawaii Capital Holdings, and Leeana Smith-Ryland remains the sole member of CS Wilton Group, LLC.
- -1050 Piiholo LLC is the sole Limited Partner, with 99% equity/capital interest in the licensee, but no right to control, manage, or operate the licensee business, other than the right to give consent to certain major corporate decisions and actions, as described above. Neil Strumingher remains the sole member of 1050 Piiholo.
