
Description of Transaction Attachment E

Pursuant to Section 25.119(h) of the Commission's rules, 47 C.F.R. § 25.119(h), the Commission is hereby notified of the *pro forma* assignment of earth station authorizations E181373 and E181376 held by Layer3 TV, Inc. As part of an internal corporate reorganization involving indirect wholly owned subsidiaries of T-Mobile US, Inc., Layer3 TV, Inc. was converted into a limited liability company, Layer3 TV, LLC. The transaction occurred on December 31, 2020 and resulted in the *pro forma* assignment of earth station authorizations E181373 and E181376.


Attached are charts showing the ownership of authorization holder before and after the transaction.

Public Interest Statement Exhibit F

The transaction described in Exhibit E resulted from a planned internal corporate reorganization involving indirect wholly owned subsidiaries of T-Mobile US, Inc. Because the reorganization did not change the ultimate control of the license (it will remain controlled by T-Mobile US), it was *pro forma* in nature.¹ The Commission has stated that, in situations "where no substantial change of control will result from the transfer or assignment, grant of the application is deemed presumptively in the public interest."²
