On behalf of Thrane & Thrane Airtime Ltd., this letter is being submitted in response to a request from the International Bureau staff to identify the geographic location of the gateway land earth stations ("LES") that are used in connection with Inmarsat's Broadband Global Area Network ("BGAN") service. These Inmarsat BGAN LESs are located in Burum, Netherlands (primary) and Fucino, Italy (alternate). The latitude, longitude and altitude of the LES locations are: (1) Burum, Netherlands: 53.285°N, 6.218°E, altitude 0.009 km; and (2) Fucino, Italy: 41.981°N, 13.392°E, altitude 0.65 km.
