The requested earth station consists of a high gain, transmit/receive antenna that will communicate with the Globalstar satellites. The purpose of this facility is constellation maintenance and stationkeeping. For example, the earth station will be used in the process of in-orbit testing of the satellites, for life testing to determine whether performance has degraded in-orbit, and for review of system performance.
