License for a 2.4 meter Ku-band transmit/receive earth station in Boxborough, Ma. will support the Network Operations Center for the Joint Capability Technology Demonstration (JCTD) of the IRIS program for the Department of Defense (DOD). The payload for the IRIS program will reside on Intelsat's IS-14 satellite scheduled to launch in late 2009. The extended Ku-band operation in the frequency ranges of 10.95 - 11.20 and 11.45 - 11.70 GHz will be limited to operations with Intelsat IS-14 and the IRIS program. Standard Ku-band operation may be utilized at various times in the 11.7 - 12.2 GHz range with other Permitted List satellites in that band.
