Analysis of Non-Ionizing Radiation for a 2.4-Meter Earth Station System

This report analyzes the non-ionizing radiation levels for a 2.4-meter earth station system. The analysis and calculations performed in this report comply with the methods described in the FCC Office of Engineering and Technology Bulletin, No. 65 first published in 1985 and revised in 1997 in Edition 97-01. The radiation safety limits used in the analysis are in conformance with the FCC R&O 96-326. Bulletin No. 65 and the FCC R&O specifies that there are two separate tiers of exposure limits that are dependant on the situation in which the exposure takes place and/or the s tatus of the individuals who are subject to the exposure. The Maximum Permissible Exposure (MPE) limits for persons in a General Population/Uncontrolled environment are shown in Table 1. The General Population/Uncontrolled MPE is a function of transmit frequency and is for an exposure period of thirty minutes or less. The MPE limits for persons in an Occupational/Controlled environment are shown in Table 2. The Occupational MPE is a function of transmit frequency and is for an exposure period of six minutes or less. The purpose of the analysis described in this report is to determine the power flux density levels of the earth station in the far-field, n ear-field, transition region, between the subreflector or feed and main reflector surface, at the main reflector surface, and between the antenna edge and the ground and to compare these levels to the specified MPEs.

1. Far Field Distance Calculation

The distance to the beginning of the far field can be determined from the following equation:

The maximum main beam power density in the far field can be determined from the following equation:

2. Near Field Calculation

Power flux density is consider ed to be at a maximum value throughout the entire length of the defined Near Field r egion. The region is con tained within a cy lindrical volume having the same diameter as the antenna. Past the boundary of the Near Field region, the power density from the antenna decreases linearly with respect to increasing distance.

The distance to the end of the Near Field can be determined from the following equation:

3. Transition Region Calculation

The Transition r egion is locat ed bet ween the Near and Far Field r egions. The power density begins to decrease linearly with increasing distance in the Transition r egion. While the power density decreases inversely with distance in the Transition region, the power density decreases inversely with the square of the distance in the Far Field r egion. The maximum power density in the Transition region will not exceed that calculated for the Near Field r egion. The power density calculated in Section 1 is the highest power density the antenna can produce in any of the regions away from the antenna. The power density at a distance R_t can be determined from the following equation:

4. Region between the Feed Assembly and the Antenna Reflector

Transmissions from the feed assembly are directed toward the antenna reflector surface, and are confined within a conical shape defined by the type of feed assembly. The most common feed assemblies are waveguide flanges, horns or subreflectors. The energy between the feed assembly and reflector surface can be calculated by determining the power density at the feed assembly surface. This can be determined from the following equation:

5. Main Reflector Region

The power density in the main reflector is determined in the same manner as the power density at the feed assembly. The area is now the area of the reflector aperture and can be determined from the following equation:

6. Region between the Reflector and the Ground

Assuming uniform illumination of the reflector surface, the power density between the antenna and the ground can be determined from the following equation:

8. Conclusions

Based upon the above analysis, it is concluded that harmful levels of radiation may exist in those regions noted for the Uncontrolled (Table 4) and Controlled (Table 5) environments.

The earth station will be installed on the roof of an 8' High Box Truck. Public access to the roof is restricted.

The applicant will ensure that the main beam of the antenna will be pointed at least one diameter away from any buildings, or other obstacles in those areas that exceed the MPE levels. Since one diameter removed from the center of the main beam the levels are down at least 20 dB, or by a factor of 100, public safety will be ensured.

The earth station will marked with the standard radiation hazard warnings, as well as the area in the vicinity of the earth station, to inform those in the general population, who may be working, or otherwise present on the roof, and in or near, the main beam of the antenna.

Finally, occupational exposure will be limited, and the transmitter will be turned off during periods of maintenance, so that the MPE standard of 5.0 mw/cm**2 will be complied with for those regions in close pr oximity to the main reflector, and subreflector, which could be occupied by operating personnel.
