Hughes Network Systems, LLC (“HNS”) is a wholly-owned subsidiary of Hughes Communications, Inc. (“HCI”), a Delaware Corporation. HCI, in turn, is a wholly-owned indirect subsidiary of EchoStar Corporation (“EchoStar”), a publicly traded Nevada corporation. The stockholders of record owning and/or voting 10 percent or more of the voting stock of EchoStar are:

Mr. Gouger also remains a Partner with the law firm of Gouger, Franzmann & Redman, LLC, located at 400 Inverness Parkway, Suite 250, Englewood, Colorado 80112. In his capacity as trustee, subject to certain restrictions, Mr. Gouger holds, and has the ability to exercise voting power over, shares representing 11.8% of the equity interests (assuming conversion of all shares of outstanding Class B Common Stock into Class A Common Stock) and 11.0% of the voting interests in EchoStar (assuming no conversion of Class B Common Stock).
