### **H) Special and General Provisions**

- A) This RADIO STATION AUTHORIZATION is granted subject to the following special provisions and general conditions:
  - 5 --- Licensee must notify the Commission when this earth station is no longer operational or when it has not been used to provide any service during any 6-month operation.
  - 6 --- Licensee must comply with the license modification and notification requirements of 47 CFR § 25.118 to change the coordinates of its authorized earth station.
- 55248 --- Operations in the 27.5-28.0 GHz and 28.1-28.35 GHz (Earth-to-space) frequency bands are authorized based on a demonstration of compliance with 47 CFR § 25.136(a)(4). Consequently, this earth station may operate without providing any additional interference protection to stations in the Upper Microwave Flexible Use Service (UMFUS) in the 27.5-28.0 GHz and 28.1-28.35 GHz frequency bands.
- 55249 --- Operations in the 47.2-48.2 GHz (Earth-to-space) frequency band are authorized pursuant to 47 CFR § 25.136(d)(4). Consequently, this earth station may operate without providing any additional interference protection to stations in the Upper Microwave Flexible Use Service (UMFUS) in the 47.2-48.2 GHz frequency band.
- 55250 --- Operations in the 50.4-51.4 GHz (Earth-to-space) frequency band are authorized pursuant to 47 CFR § 25.136(e)(3). Consequently, this earth station may operate without providing any additional interference protection to stations in the Upper Microwave Flexible Use Service (UMFUS) in the 50.4-51.4 GHz frequency band.
- 55251 --- The earth station licensee is required to take corrective action to mitigate interference in the 27.5-28.0 GHz, 28.1-28.35 GH and 47.2-48.2 GHz frequency bands if the actual PFD, at ten meters above ground level, exceeds -77 .6 dBm/m2/MHz anywhere outside the contour specified in the application.
- 55252 --- The requests for waiver of the frequency coordination requirements in 47 CFR § 25.130(b) (now section 25.115(a)(6)), 47 CFR § 25.203, and 47 CFR § 25.217(c)(3) are DISMISSED as moot. HNS's application, as supplemented, meets the frequency coordination requirements.
- 55253 --- The request for a waiver of 47 CFR § 25.133(a)(1) regarding completion of construction of its earth station is DENIED. HNS has not demonstrated an overriding public interest or unforeseen circumstance warranting a waiver of the rule. HNS's alternative request for additional time to comply with 47 CFR § 25.133(a)(1) is DISMISSED without prejudice to refiling at a later date, closer in time to the deadline and based on the facts at that time.
- 55254 --- The request for a limited waiver of 47 CFR § 25.132(b)(1) of the Commission's rules with respect to the timing of the submission of antenna performance information is GRANTED. HNS must submit the antenna performance information required in section 25.132(b)(1) when filing its certification pursuant to section 25.133(b)(1).
- 55255 --- The request for a waiver of 47 CFR § 25.202(a) regarding HNS operations in the 50.4-51.4 GHz band is DISMISSED as moot. HNS operations in this band comply with the rules recently adopted in FCC 19-30.
- 55256 --- The request for waiver of 47 CFR § 25.217(e) is DENIED. HNS has failed to demonstrate good cause for a waiver and must comply with frequency band-specific service rules that may be developed in the future, e.g., rules that define conditions for frequency sharing between two geostationary satellite networks operating in the 40-42 GHz, 47.2-50.2 GHz, and 50.4-51.4 GHz frequency bands, as required by 47 CFR § 25.217(e).

## H) Special and General Provisions

- A) This RADIO STATION AUTHORIZATION is granted subject to the following special provisions and general conditions:
- 90398 --- Changes to previously authorized transmitting facilities, operations and devices regulated by the Commission that may have significant environmental impact, and are not excluded by §1.1306, require the preparation of an Environmental Assessment (EA) by the licensee. (See 47 C.F.R. §§1.1307, 1.1308 and 1.1311)
- 90399 --- The licensee shall, at all times, take all necessary measures to ensure that operation of this (these) authorized earth station(s) does not create potential exposure of humans to radiofrequency radiation in excess of the FCC exposure limits defined in 47 CFR §§ 1.1307(b) and 1.1310. Physical measures must be taken to ensure compliance with limits for both occupational/controlled exposure and for general population/uncontrolled exposure, as defined in these rule sections. Compliance can be accomplished in most cases by appropriate restrictions, such as fencing. Requirements for restrictions can be determined by predictions based on calculations, modeling, or by field measurements. The FCC's OET Bulletin 65 (available on-line at www.fcc.gov/oet/rfsafety) provides information on predicting exposure levels and on methods for ensuring compliance, including the use of warning and alerting signs and protective equipment for workers.

B) This RADIO STATION AUTHORIZATION is granted subject to the additional conditions specified below:

This authorization is issued on the grantee's representation that the statements contained in the application are true and that the undertakings described will be carried out in good faith.

This authorization shall not be construed in any manner as a finding by the Commission on the question of marking or lighting of the antenna system should future conditions require. The grantee expressly agrees to install such marking or lighting as the Commission may require under the provisions of Section 303(q) of the Communications Act. 47 U.S.C. § 303(q).

Neither this authorization nor the right granted by this authorization shall be assigned or otherwise transferred to any person, firm, company or corporation without the written consent of the Commission. This authorization is subject to the right of use or control by the government of the United States conferred by Section 706 of the Communications Act. 47 U.S.C. § 706. Operation of this station is governed by Part 25 of the Commission's Rules. 47 C.F.R. Part 25.

This authorization shall not vest in the licensee any right to operate this station nor any right in the use of the designated frequencies beyond the term of this license, nor in any other manner than authorized herein.

This authorization is issued on the grantee's representation that the station is in compliance with environmental requirements set forth in Section 1.1307 of the Commission's Rules. 47 C.F.R. § 1.1307.

This authorization is issued on the grantee's representation that the station is in compliance with the Federal Aviation Administration (FAA) requirements as set forth in Section 17.4 of the Commission's Rules. 47 C.F.R.§ 17.4.

The following condition applies when this authorization permits construction of or modifies the construction permit of a radio station.

This authorization shall be automatically forfeited if the station is not ready for operation by the required date of completion of construction unless an application for modification of authorization to request additional time to complete construction is filed by that date, together with a showing that failure to complete construction by the required date was due to factors not under control of the grantee.

Licensees are required to pay annual regulatory fees related to this authorization. The requirement to collect annual regulatory fees from regulatees is contained in Public Law 103-66, "The Omnibus Budget Reconciliation Act of 1993." These regulatory fees, which are likely to change each fiscal year, are used to offset costs associated with the Commission's enforcement, public service, international and policy and rulemaking activities. The Commission issues a Report and Order each year, setting the new regulatory fee rates. Receive only earth stations are exempt from payment of regulatory fees.
