H) Special and General Provisions

A) This RADIO STATION AUTHORIZATION is granted subject to the following special provisions and general conditions:

- 90398 --- Changes to previously authorized transmitting facilities, operations and devices regulated by the Commission that may have significant environmental impact, and are not excluded by §1.1306, require the preparation of an Environmental Assessment (EA) by the licensee. (See 47 C.F.R. §§1.1307, 1.1308 and 1.1311)
- 90399 --- The licensee shall, at all times, take all necessary measures to ensure that operation of this (these) authorized earth station(s) does not create potential exposure of humans to radiofrequency radiation in excess of the FCC exposure limits defined in 47 CFR §§ 1.1307(b) and 1.1310. Physical measures must be taken to ensure compliance with limits for both occupational/controlled exposure and for general population/uncontrolled exposure, as defined in these rule sections. Compliance can be accomplished in most cases by appropriate restrictions, such as fencing. Requirements for restrictions can be determined by predictions based on calculations, modeling, or by field measurements. The FCC's OET Bulletin 65 (available on-line at www.fcc.gov/oet/rfsafety) provides information on predicting exposure levels and on methods for ensuring compliance, including the use of warning and alerting signs and protective equipment for workers.
- 90491 --- Operations in the 27.5-28.35 GHz (Earth-to-space) frequency band are authorized based on a demonstration of compliance with 47 CFR § 25.136(a)(4). Consequently, this earth station may operate without providing any additional interference protection to stations in the Upper Microwave Flexible Use Service (UMFUS) in the 27.5-28.35 GHz frequency band.
- 90530 --- The earth station licensee is required to take corrective action to mitigate interference in the 27.5-28.35 GHz frequency band if the actual PFD, at ten meters above ground level, exceeds -77 .6 dBm/m2/MHz anywhere outside the contour specified in the application.
- 90572 --- Since the PFD contour was calculated based on a power density at the input of the earth station antenna which is 3.9 dB lower than the maximum power density specified in the application, this reduced power density is the maximum level that can be used.
- 90573 --- To the extent that the actual gain pattern of the antenna ultimately deployed by the licensee exceeds the antenna mask used in the calculation of the PFD contour, the contour resulting from the actual antenna pattern must continue to meet all of the criteria specified in 47 CFR § 25.136(a)(4)(i-iv).
- 90623 --- Operations in the 17.8-18.3 GHz frequency band are on a secondary basis to the Fixed Service (FS). Licensee must accept any interference from existing and future FS transmissions in the 17.8-18.3 GHz frequency band."
- 90650 --- Grant of this application is subject to operations consistent the associated space station authorizations(s) or grant(s) of U.S. market access, including all conditions, waivers, and findings therein.
- 900631 --- Grant of operations in the 27.5-28.35 GHz frequency band is based on the applicant's calculation of the aggregate population affected by all earth stations in the county, under 47 CFR §25.136(a)(4)(ii), using the "actual area method." For Pondera County, in the State of Montana, the estimated population affected by this earth station was determined to be 290 people, out of a maximum of 450 people allowed to be affected in this County, based on the decennial 2010 U.S. Census Population information.

H) Special and General Provisions

A) This RADIO STATION AUTHORIZATION is granted subject to the following special provisions and general conditions:

900632 --- WorldVu Satellites Limited (OneWeb) filed a Petition for Reconsideration and Petition to Condition SpaceX's NGSO satellite system modification application and this application, to which SpaceX responded. See Comments of WorldVu Satellites Limited (filed May 28, 2019); SpaceX Opposition (filed June 10, 2019). The Bureau addressed this petition by granting in part and denying in part in the context of SpaceX's space station modification application. See Space Exploration Holding, LLC, Request for Modification of the Authorization for the SpaceX NGSO Satellite System, 35 FCC Rcd 5649 (June 4, 2020). In addition, Echostar Satellite Operating Corporation and Hughes Network System, LLC (collectively "Echostar"), Intelsat License LLC, and AT&T Services Inc. (collectively, "GSO Operators") filed Comments and Petition to Condition, to which SpaceX responded. See Comments and Petition to Condition of Echostar Satellite Operating Corporation and Hughes Network System, LLC, Intelsat License LLC, and AT&T Services Inc. (filed July 12, 2019); SpaceX Response to GSO Operators (filed July 25, 2019). The issues raised in the GSO petition were addressed by the Commission in the SpaceX Modification Order and Authorization and Order on Reconsideration. See Space Exploration Holdings, LLC, Order and Authorization and Order on Reconsideration, FCC 21-48 (April 23, 2021) at paras. 40, 41. As a result, we dismiss these petitions as moot.

B) This RADIO STATION AUTHORIZATION is granted subject to the additional conditions specified below:

This authorization is issued on the grantee's representation that the statements contained in the application are true and that the undertakings described will be carried out in good faith.

This authorization shall not be construed in any manner as a finding by the Commission on the question of marking or lighting of the antenna system should future conditions require. The grantee expressly agrees to install such marking or lighting as the Commission may require under the provisions of Section 303(q) of the Communications Act. 47 U.S.C. § 303(q).

Neither this authorization nor the right granted by this authorization shall be assigned or otherwise transferred to any person, firm, company or corporation without the written consent of the Commission. This authorization is subject to the right of use or control by the government of the United States conferred by Section 706 of the Communications Act. 47 U.S.C. § 706. Operation of this station is governed by Part 25 of the Commission's Rules. 47 C.F.R. Part 25.

This authorization shall not vest in the licensee any right to operate this station nor any right in the use of the designated frequencies beyond the term of this license, nor in any other manner than authorized herein.

This authorization is issued on the grantee's representation that the station is in compliance with environmental requirements set forth in Section 1.1307 of the Commission's Rules. 47 C.F.R. § 1.1307.

This authorization is issued on the grantee's representation that the station is in compliance with the Federal Aviation Administration (FAA) requirements as set forth in Section 17.4 of the Commission's Rules. 47 C.F.R. § 17.4.

The following condition applies when this authorization permits construction of or modifies the construction permit of a radio station.

This authorization shall be automatically forfeited if the station is not ready for operation by the required date of completion of construction unless an application for modification of authorization to request additional time to complete construction is filed by that date, together with a showing that failure to complete construction by the required date was due to factors not under control of the grantee.

Licensees are required to pay annual regulatory fees related to this authorization. The requirement to collect annual regulatory fees from regulatees is contained in Public Law 103-66, "The Omnibus Budget Reconciliation Act of 1993." These regulatory fees, which are likely to change each fiscal year, are used to offset costs associated with the Commission's enforcement, public service, international and policy and rulemaking activities. The Commission issues a Report and Order each year, setting the new regulatory fee rates. Receive only earth stations are exempt from payment of regulatory fees.
