Pursuant to Section 1.65 of the Federal Communications Commission's rules, 47 C.F.R. § 1.65, Speedcast Communications, Inc. ("Speedcast") hereby provides an update regarding the coordination status of Speedcast's request for authority to conduct lower-power earth station operations in connection with the above-referenced applications.

As described in the attached letter, Speedcast's frequency coordinator has received responses to the prior coordination notice describing the lower-power operations and consent to proceed with the operations from the following entities:

Importantly, responses from terrestrial licensees were received from their frequency coordinator, which also coordinated conditions associated with Speedcast's proposed higher-power operations. No potential for interference was indicated to any other systems in the notification range, no additional responses are expected, and operation at the proposed lower power should not result in harmful interference to any terrestrial licensee.

As you know, we have issued a prior coordination notice (“PCN”) for the lower-power operations proposed in Speedcast’s fixed earth station license application (Call Sign E210125; File Nos. SES-LIC-20210628-00992 and SES-AMD-20210817-01483) and STA request (File No. SES-STA-20210610-00877). In addition to consent from the Arecibo Observatory, the following companies have responded and given clearance to proceed with these lower-power operations:
