Additionally, there will be a total of twenty-two (22) portable (remote) earth stations used for the recovery of communications during a natural or man-made disaster affecting the system. An encrypted digital bent-pipe would be setup between either the Hub and a portable station, or between two portables using bandwidth on a U.S. satellite. The portable earth stations will all be located within the U.S. and its territories as determined by the disaster recovery in progress.
