1. Summary of Results

On behalf of ViaSat. Inc., Comsearch issued coordination notice under Section 25.203(c) and Section 25.136(a)(4) of the FCC's rules for all existing and proposed terrestrial licenses within the coordination contours of their proposed Ka-Band earth station in Clarksburg-WV, which will transmit at 28 GHz¹. Prior-notification emails were sent to the licensees and a copy of the notification data is provided in section four of this report. The earth station coordination was finalized on July 29, 2021.

No objections were received from any of the incumbent 28 GHz licensees.

2. 28 GHz UMFUS Coordination

All 28 GHz UMFUS licensees within the coordination distance of the proposed earth station were identified. The proposed earth station will operate on frequencies that overlap Channel L1 & L2 of the UMFUS service. The total frequency allocation for Channels L1 & L2 of the UMFUS spectrum appears below.

Channel: L1 27.500 - 27.925 GHz

L2 27.925 - 28.350 GHz
