The extensive public interest benefits of providing service to the U.S. from the 118.7 orbital location are discussed in the original application. SES Americom is concurrently filing a modification application to relocate the AMC-16 satellite to 118.75 to provide service pending the launch of ANIK F3 satellite to this orbital location. A copy of the agreement between EchoStar, Telesat, and SES Americom related to the operation of AMC-16 at 118.75 is attached to this application. This is the only change requested by this amendment.
