The modification adds Eutelsat 172A, Intelsat 904, Satmex 5, and SES-6 as authorized points of communications. It modifies the terms of operation of SES-1 and NSS703 to reflect higher coordinated power levels, and revises the license conditions to reflect changes due to the recently adopted ESAA Order.
