Mr. Blais,

I am following up on my January 5, 2016 telephone call to you in which I sought permission to correct errors in the responses asserting applicant's compliance with Sections 25.222 (c) & (d) that were set forth on the last page of the "Narrative & Part 25 Compliance" exhibit submitted with the SES-MFS-20150130-00047 Modification Application. The last sentence of the response for 25.222 (c) stated –

Until the coordination process is completed ASGI will continue to comply with 25.222 (c) by not operating Ku-band ESVs at all in the 14.47 – 14.5 GHz frequency band within the specified distances of the protected facilities.

The sentence should state –

Until the coordination process is completed ASBCI will continue to comply with 25.222 (c) by not operating Ku-band ESVs at all in the 14.0 – 14.2 GHz frequency band within the specified distances of the protected facilities.

The response for 25.222 (c) stated –

(d) Comply. ASGI does not operate any ESVs in the 14.47 – 14.5 GHz frequency band.

The response should state –

(d) Comply. Until the coordination process is completed ASBCI will continue to comply with 25.222 (d) by not operating Ku-band ESVs at all in the 14.47 – 14.5 GHz frequency band within the specified distances of the protected facilities.

As per your instruction I prepared the attached correction request and am adding it and this email to the file via the IBFS Pleadings and Comments tool. Could you please accept this correction request and bring it to the attention of the engineer handling the SES-MFS-20150130-00047 Modification Application.
