> I have just submitted an amendment to a pending modification application (earth station) and wanted to give you a heads-up. I don't know that I did it as you would instruct, but it was the only way I could figure out (on my own) how to get the information submitted.

> The pending mod is SES-MOD-20000326-00462 (PN date 4/12/00)
> The amendment application (dated 4/21/00) was assigned submission ID# IB2000000300. No fee is required because TUPR (applicant) is a government entity.

>

> By this amendment, I am correcting emission designator and EIRP density information on the underlying authorization. The density is LOWER than that on original application, and the complete information is provided on Attachment 2. Although this info would typically be provided on Schedule B, I could not figure out how to access it electronically.

> Also, I tried to "connect" this amendment to the pending mod by inputting the pending mod application number and filing date at Main Form Item 19, but I could not get it submitted doing that, so I had to go back to the most recent approved application file number. The mod file number is in

> the current filing's description.
