**43. Description. (Summarize the nature of the application and the services to be provided).**

This application requests modification of earth station authorization E030005 (SES-LIC-20021219-02184) to add as a point of communication space station S2191 at 103 degrees W.L. This satellite has been coordinated with the U.S. Government. In addition, this application corrects the common name of the points of communication at 99 degrees W.L. and 101 degrees W.L. to be S2133 and S2132, respectively. Also, this application requests authorization to modify the license by increasing the maximum input power for the fixed 1.8 meter transmit/receive terminal to the 8.5 watts at the antenna flange from the currently authorized 3.5 watts in order to provide higher propagation availability. Finally, this application corrects the dimensions of the 3.5 meter antenna.
