Licensee seeks authority to convert E950257 into a standard Ku-Band T/R license, to increase EIRP and EIRP density, and to add a video emission designator. Upon grant, licensee will surrender the licenses for the remote VSATs (E950258 & E950259 are the call signs for the VSATs).
