At the request of Ms. Nguyen, we have sought clarification of your questions regarding the emissions designator and the maximum EIRP density per carrier for the above modification application. Please amend the pending modification designator to change the emissions designator from "307K61D" to "307KG1D" and to reduce the maximum EIRP density per carrier from 42.3 dBW/4 kHz to 38.1 dBW/4 kHz to meet the Section 25.212(c) input power density limit. We appreciate your cooperation in moving this application towards PN. Have a happy holiday and let me know if you have any further questions.
