Nov. 1, 2001); *see also Stratos Offshore Services Company*, File No. SES-T/C-20030924-01322 (approving divestiture of Aliant, Inc.). Currently, Stratos Offshore Services Company (“Stratos”), a Delaware corporation, is wholly owned by Stratos Holdings, Inc. (“Stratos Holdings”), a Delaware corporation with offices at 6901 Rockledge Drive Suite 900, Bethesda, MD, 20852. In turn, Stratos Holdings is wholly owned by Stratos Wireless, Inc. (“Stratos Wireless”), a company incorporated under the laws of Canada with offices at 34 Glencoe Drive, Donovan’s Business Park, Mount Pearl, Newfoundland AIN 4S8, Canada. Stratos Wireless is wholly owned by Stratos Global Corporation (“Stratos Global”), a Canada corporation with offices at 34 Glencoe Drive, Donovan’s Business Park, Mount Pearl, Newfoundland AIN 4S8, Canada.

At the request of International Bureau staff, this Amendment is being filed by Stratos Offshore Services Company ("Stratos") to correct several typographical errors in the ESV modification application filed by Stratos. *See* File No. SES-MOD-20060609-00965. Specifically, the following items should be corrected:

1. The latitude and longitude (E12/E13) provided for Hub-2 in the application should state:

Latitude: 30 degrees, 14' 36.7" N

Longitude: 92 degrees, 3' 6.4" W

2. For Remote 4, the Antenna Elevation Angle Eastern Limit (E57) and Antenna Elevation Angle Western Limit (E59) should state: 15.0
3. For Remote 4, the Earth Station Azimuth Angle Eastern Limit (E56) and the Earth Station Azimuth Angle Western Limit (E58) should state: 0.0.

Stratos respectfully requests that these errors be corrected and the modification application be placed on Public Notice.
