Request of Clear Channel Satellite Services for Correction of License**

Dear Ms. Dortch:

Clear Channel Satellite Services ("Clear Channel"), by its attorneys, hereby requests that the Commission issue a corrected license for call sign E000329 to specify that the class of station is a VSAT network, rather than a temporary-fixed earth station.

The error was introduced in Clear Channel's most recent modification application for this call sign, File No. SES-MOD-20091210-01568, which was granted earlier this year. Copies of the license issued prior to grant of this modification correctly show that the call sign is for a VSAT network. However, the modification application had a typographical error in item 25, with box b (Temporary-Fixed Earth Station) checked instead of box c (12/14 GHz VSAT Network). Clear Channel did not intend to seek a change in the class of station, as evidenced by the fact that in item 17 of the application, the fee code for a VSAT network was designated (fee classification CGV). A copy of the modification application and confirmation of fee payment are attached for your reference.

Clear Channel accordingly requests that the Commission issue a corrected license for this call sign. Please direct any questions regarding this submission to the undersigned.
