This earth station facility will utilize a 2.4 meter Ku-band transmit & receive antenna to distribute digital audio program information, as well as some limited data services, to a variety of downlink earth station facilities primarily at radio stations located throughout the US. Domestic Ku-band (ALSAT) satellites are to be utilized, all are US licensed.
