**43. Description. (Summarize the nature of the application and the services to be provided).**

Modification of Call sign E990066 to add UHF-band, S-band and X-band frequencies and emissions. The UHF-band frequencies will be supported by a new Yagi-Uda antenna and the S-band and X-band frequencies will be added to the existing 7.6 meter on this license. These modifications will support the Planet Labs constellation of NGSO EESS satellites. This modification is a follow-up to the recently granted STA, File Number SES-STA-20140224-00097.
