**Re: License Modification #E000329 – FCC Form 312 (iHeartMedia, Inc.)**

Dear Ms. Dortch:

As a result of iHeartMedia, Inc.'s ("IHM") business decision to downsize its satellite services in Englewood, Colorado, iHeartMedia hereby submits FCC Form 312 requesting a Modification of License.

Please accept this attachment "B" to iHeartMedia, Inc.'s FCC Form 312 for the modification of its license #E000329. The herein application for Modification of License involves requests for the termination/deletion of several inactive Site IDs, the authorization to add antenna, the legal name change of the Licensee, the renaming of one Site ID and Antenna Facility, the designation of new remote control points at already-licensed Site IDs, the migration of several Site IDs to License #E050143 (also licensed to IHM), relocation of Site IDs to reflect address changes to the anchor location from which those antennas are deployed and a change to select emission designators. The requested modifications are listed as below:

**(a) Termination of Inactive Site IDs**

Please find below an index of the **line entries** (as listed in the downloadable PDF-version of license #E000329, FCC Form 488) that are inactive Site IDs and ought to be **removed** from the license.

**(b) Authorization to Add Antenna**
