This modification to SES-LIC-20070928-01335 seeks additional authority to communicate with Telstar 12 Vantage, the replacement for Telstar 12 and includes a study demonstrating compliance of the proposed operation with FCC Report & Order (FCC96-377) for the 13.75 - 14.0 GHz Band Analysis and Calculations.
