Alascom, Inc. (Alascom) seeks to modify its Chenega Bay, AK earth station (Call Sign K7242) to remove the Ka-band antenna and Ka-band frequencies from the current authorization. (Although the Commission previously granted Alascom's request to add Ka-band frequencies and a 1.2-meter Ka-band antenna to the earth station authorization in IBFS File No. SES-MOD-20191107-01465, Alascom notes that the current license does not appear to have been updated to reflect these changes.) Alascom certifies that the remaining license information has not changed, and such information is incorporated by reference. For the avoidance of doubt, Alascom does not seek to modify the earth station's C-band antenna or frequencies by this application.
