

Exhibit C – Administrative Updates

Summary

SageNet LLC (“SageNet”) is requesting administrative updates to call sign E000035 for the 0.75-meter earth station antenna to reflect changes in SageNet’s VSAT network operations and Federal Communication Commission regulations as detailed in this exhibit for designated Remote Control points and downlink EIRP density limit.

Remote Control Point Updates

SageNet requests the following changes to section “F) Remote Control” in the authorization.

Adding Remote Control Points

This application requests two new Sites IDs to be added to the authorization, “REMOTE 3” and “REMOTE 4” associated with the 0.75-meter Antenna IDs “0.75MA” and “0.75MTFA” respectively, both with ALSAT designation. The Remote Control points for the two added Site IDs have the following characteristics:

Removal of McLean, VA as a Remote-Control Point

SageNet has surrendered Commission earth station authorization call signs E990448, E990552 and E860326, and removed all operations from the former SageNet McLean, VA facility, that supported SageNet VSAT network hub earth station services in the past. VSAT network hub operations continue to be supported from the SageNet facilities listed for Marietta, GA and Chicago, IL. SageNet requests removal from Section F for the McLean, VA facility call signs: E990448, E990552 and E860326 as noted in the following table.

Commission Authorized Maximum Downlink EIRP Density

SageNet requests the removal of item number “2333” in section “H) Special and General Provisions” of call sign E000035, which limits the 0.75-meter earth station antenna to receive outbound transmissions from another earth station using GSO FSS Ku-band satellite to a downlink (earth station receive) EIRP density of +6 dBW/kHz. The Commission has updated downlink EIRP density regulations since the initial authorization of call sign E000035 to allow for higher downlink EIRP density levels. SageNet certifies that it will not operate the 0.75-meter earth station with a network exceeding the current Commission allowed downlink EIRP density of 14 dBW/4kHz for digital transmissions in the conventional Ku-band as allowed in 47 CFR 25.140(a)(3)(ii).

Operation of the 0.75-meter earth station up to the maximum allowed downlink EIRP density will provide SageNet additional flexibility in providing VSAT network communication services and will not adversely impact other licensees. To be clear the outbound downlink EIRP density provision SageNet is requesting removal is received by, not transmitted by, the 0.75-meter earth station authorized under call sign E000035. Additionally, SageNet also acknowledges that it will be limited to seeking protection from harmful interference received by the 0.75-meter earth station to the extent an earth station antenna compliant with 47 CFR 25.209 receives protection in the earth station space-to-earth conventional Ku-band. Specifically SageNet is requesting the removal of the outdated provision “2333” in call sign E000035 that states:

2333 The outbound downlink EIRP Density from the HUB station shall not exceed +6 dBW/4 KHz.
