EARTH STATION LICENSE MODIFICATION APPLICATION

COMSAT, Inc. (“COMSAT”), pursuant to Section 25.117 of the Commission’s rules, 47 C.F.R. §25.117, respectfully files this modification application associated with the above-captioned earth station license to change its status from common carrier to non-common carrier. No changes to the operational characteristics authorized by the earth station license are proposed.

This modification application is one of several filed contemporaneously¹ that are associated with the surrender of COMSAT’s international Section 214 authorizations,² which reflect that it is no longer providing services on a common carrier basis. Therefore, the change in regulatory status will not result in the discontinuance of service to existing customers. Furthermore, COMSAT does not anticipate any future business need to operate the facilities authorized by this earth station license on a common carrier basis.

COMSAT, Inc. ("COMSAT"), by its representative and via electronic filing, hereby surrenders the above-referenced international Section 214 authorization.¹ This and other Section 214 authorizations have been surrendered after a comprehensive review revealed that COMSAT's current operations do not require the large number of Section 214 authorizations accumulated and maintained over a span of more than 35 years.
