SES wishes to add emission designations to the current call sign #E070183 in order to include carriers of lower bandwidth. EIRP density of the carriers remain the same as of the currently licensed carriers, thus the new carriers shall not have any adverse effect causing higher level of interference to the adjacent satellites or to the horizon.
