This modification will also add extended Ku-band frequencies (13.75 - 14.0 GHz) to the existing 9 meter antenna on this license, as well as, the new 7.6 meter antenna. The extended Ku-band frequencies will be used on Amazonas 2 satellite at 61 degrees West Longitude.
