Scripps Broadcasting Holdings, LLC (“Scripps”) is the licensee of WTVF(TV), Nashville, Tennessee, and registrant of Receive-Only Earth Station E190541.

The instant application proposes to change the number of antenna units under E) Antenna Facilities from 4 to 3. The facility only has three C-band antennas on site. Due to the constraints of IBFS Form 312 modification applications, the form only allows for addition of new data, not removal of old.

Scripps requests the modification of its license E190541 to change the antenna units and to re-issue the license.
