Re: Request for Modification of Earth Station Registration – Call Sign E182049

Dear Ms. Dortch:

Consistent with the International Bureau’s (“Bureau”) September 27, 2021 Public Notice (“Public Notice”) regarding inactive or otherwise not operational C-Band incumbent earth station antennas,¹ Altice USA, Inc. (“Altice”) files this letter to request that the Commission modify the earth station registration associated with call sign E182049 – IBFS File No. SES-MOD-20210809-01347 – to remove the site listed below. This site is no longer operational and will not be restored to service.
