

Pursuant to the Commission's Order granting Inmarsat, Inc.'s request to streamline licensing of L-band Mobile Satellite Service terminals,¹ Honeywell International, Inc. here requests redesignation of the points of communications listed on the license for Call Sign E000156 to "ISAT." The Commission has determined that redesignation of Inmarsat points of communications to ISAT for licenses such as E000156 will "serve the public interest by eliminating duplicative and repetitive filings and by facilitating the more rapid deployment of satellite services to U.S. consumers."² Accordingly, Honeywell seeks the expeditious approval of this request.
