## **1. CONCLUSIONS**

An interference study considering all existing, proposed and prior coordinated microwave facilities within the coordination contours of the proposed earth station demonstrates that this site will operate satisfactorily with the common carrier microwave environment. Further, there will be no restrictions of its operation due to interference considerations.

## **2. SUMMARY OF RESULTS**

There was no great circle interference cases were identified during the interference study of the proposed earth station.

No microwave carriers reported potential interference cases during the coordination process for this earth station.

### **3. SUPPLEMENTAL SHOWING**
