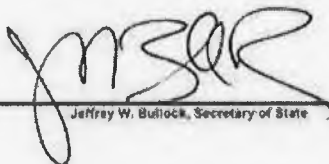

The name of the limited liability company is **CC Licenses, LLC** (the "Company").

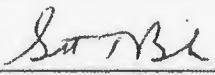
