This earth station consists of one dish used to receive signals from US-licensed satellites (ALSAT). Primary use is reception of digital radio network signals 24 hours a day. No PCN data is supplied because of FCC Public Notice DA 18-398 Dated - April 19, 2018 which indicates that a PCN is no longer required to register a receive only C-band downlink. Earth Station location is not visible in an aerial view on Google Earth because the aerial view was taken before 2016, when the earth station was built. If you switch to Google Street View, you can see the new earth station and studio building.
