**Re: Notice of Involuntary Transfer of Control of Satellite Earth Station Licenses**

ViacomCBS Inc. (ViacomCBS) hereby provides notice regarding certain applications it is required to file with the Commission due to the death of Sumner M. Redstone on August 11, 2020. Mr. Redstone held an indirect interest in ViacomCBS, which in turn controls each of the entities holding the satellite Earth station licenses listed in the Attachment to this letter. Mr. Redstone also held an indirect interest through ViacomCBS in other licenses issued under Title III of the Communications Act, including broadcast television and related licenses for which a similar notice was provided on August 13, 2020.<sup>1</sup>

ViacomCBS is in the process of gathering the necessary information and is preparing to file all applications related to the involuntary transfer of control of its FCC licenses, including the listed satellite Earth station licenses, within 30 days of Mr. Redstone's death. This approach will ensure that ViacomCBS has adequate time to complete these applications and enable it to submit all relevant filings on the same schedule.<sup>2</sup>

<sup>2</sup> See 47 C.F.R. §§ 1.948(g) & 73.3541(b) (requiring involuntary transfer of control applications for wireless licenses and broadcast licenses, respectively, to be filed within 30 days of the triggering event). Section 25.119(d) of the Commission's rules, which applies to satellite Earth station licenses, specifies that involuntary transfer of control applications should be filed "within 10 days of the event causing the transfer of control." 47 C.F.R. § 25.119(d).
