A) This RADIO STATION AUTHORIZATION is granted subject to the following special provisions and general conditions:

90472 --- The application for this authorization was filed without a coordination report pursuant to the waiver granted in Public Notice DA 18-398 (rel. Apr. 19, 2018). Operations of this earth station in the 3700-4200 MHz band are not entitled to protection from stations operating in the fixed service.

900407 --- The Permitted Space Station List (Permitted List) is a list of all geostationary space stations providing fixed-satellite service pursuant to a Commission license or grant of U.S. market access. Licensees are required to pay annual regulatory fees related to this authorization. The requirement to collect annual regulatory fees from regulatees is contained in Public Law 103-66, "The Omnibus Budget Reconciliation Act of 1993." These regulatory fees, which are likely to change each fiscal year, are used to offset costs associated with the Commission's enforcement, public service, international and policy and rulemaking activities. The Commission issues a Report and Order each year, setting the new regulatory fee rates. Receive only earth stations are exempt from payment of regulatory fees.
