Dear International Bureau:

This letter is in response to the Bureau’s email of October 21, 2020. Please be advised the above-referenced registration for E201047 (copy attached) indicate two antennas are in service at that location, a 3.0 meter Comtech and a 3.8 meter Comtech. Accordingly, with respect to E201047, CBSL filed a lump sum reimbursement election for two multi-feed antennas (copy attached).

The August 3<sup>rd</sup> Incumbent List, however, incorrectly references only single antenna. We respectfully request that the Incumbent List be corrected to list E201047 as having two antennas and that CBSL’s lump sum election be processed.

A separate filing has been submitted with respect to CBSL’s E201046 to report that only one of the two antennas referenced in that registration is in service.

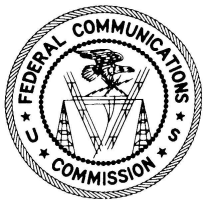
In our review of the other lump sum reimbursement elections submitted for CBSL (i.e., for E201056, E201060 and E201062), we found no other discrepancies.

A) This RADIO STATION AUTHORIZATION is granted subject to the following special provisions and general conditions:

Any changes must be filed electronically in the International Bureau Filing System (MyIBFS) using the "Pleadings and Comments" link on the MyIBFS homepage within 10 days of the change.
- 6 Licensee must comply with the license modification and notification requirements of 47 CFR § 25.118 to change the coordinates of its authorized earth station.
- 8 Licensee must notify the Commission when all earth stations operating under this authorization are no longer operational or when they have not been used to provide any service during any 6-month operation.

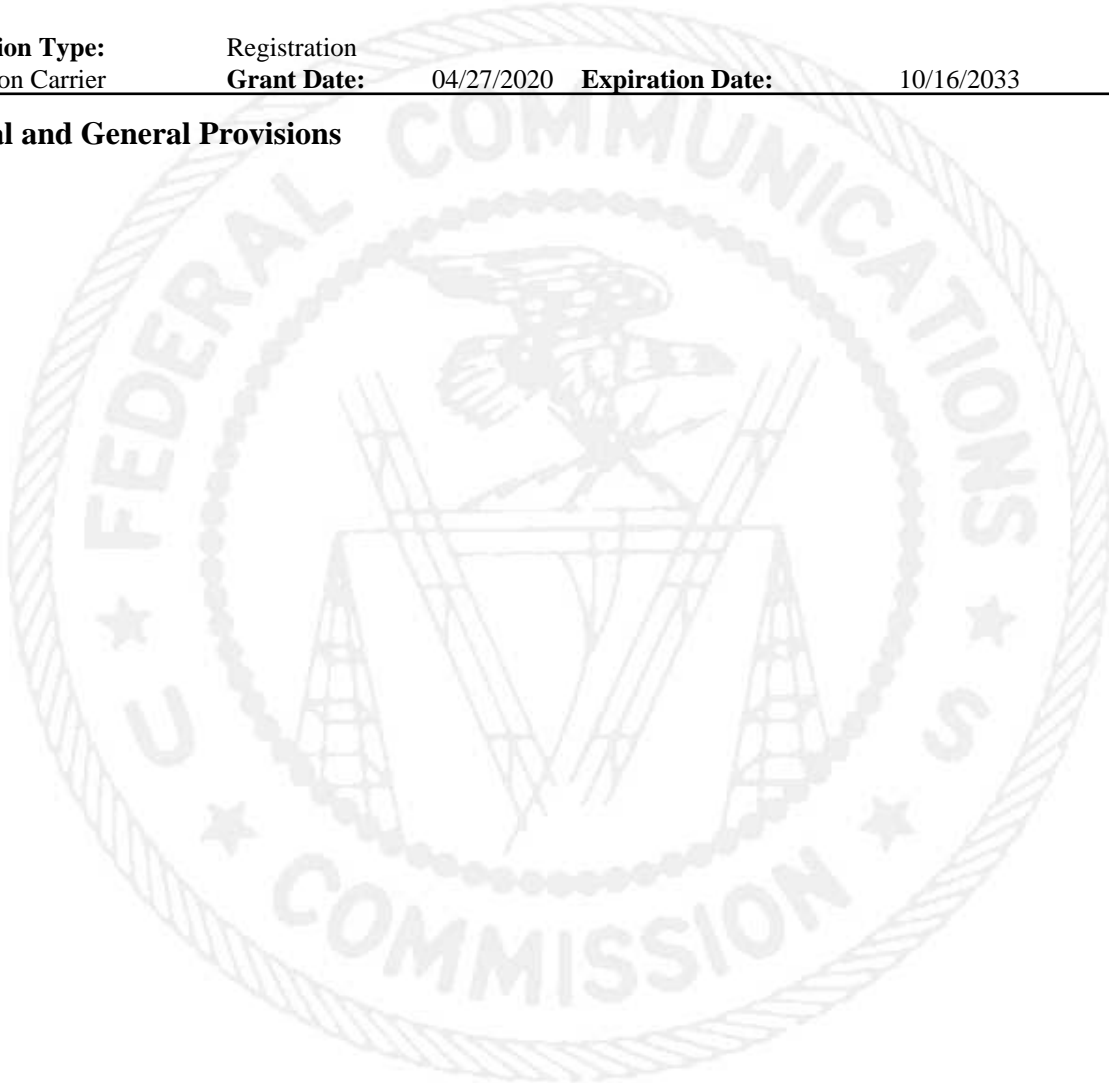

## H) Special and General Provisions

B) This RADIO STATION AUTHORIZATION is granted subject to the additional conditions specified below:

This authorization is issued on the grantee's representation that the statements contained in the application are true and that the undertakings described will be carried out in good faith.

This authorization shall not be construed in any manner as a finding by the Commission on the question of marking or lighting of the antenna system should future conditions require. The grantee expressly agrees to install such marking or lighting as the Commission may require under the provisions of Section 303(q) of the Communications Act. 47 U.S.C. § 303(q).

Neither this authorization nor the right granted by this authorization shall be assigned or otherwise transferred to any person, firm, company or corporation without the written consent of the Commission. This authorization is subject to the right of use or control by the government of the United States conferred by Section 706 of the Communications Act. 47 U.S.C. § 706. Operation of this station is governed by Part 25 of the Commission's Rules. 47 C.F.R. Part 25.

This authorization shall not vest in the licensee any right to operate this station nor any right in the use of the designated frequencies beyond the term of this license, nor in any other manner than authorized herein.

This authorization is issued on the grantee's representation that the station is in compliance with environmental requirements set forth in Section 1.1307 of the Commission's Rules. 47 C.F.R. § 1.1307.
