Will do that. The red light thing is from a sat truck we sold in 2019 and the new owner never transferred the license because he made it into a RV camper and scrapped the dish. The fact that I have to pay for a license on a dish we don't own any more is pretty annoying. I just thought it would expire if I didn't renew it. However there is something worse maybe you can help me with. We bought a truck in 2019 that came with license E050245. It is a dual band C/Ku truck. I applied for (and paid for) the transfer in August 2019, it took the FCC 6 months to tell me I was missing something on the application, which I promptly respond with, and I asked them very specifically if there was anything else needed. I was told "no, good to go". When it still showed in the previous owners name 2 weeks later I followed up and they told me it was on public file for 30 days and would then go through, so I did nothing. They did not tell me about this new secret rule not mentioned anywhere on the IBFS website that you have to tell the FCC that you "consumated" the transfer (as if putting up \$500 for the transfer was not proof enough), which I didn't do because I had no idea about it (my last truck purchase in 2008 didn't have any consummating needed) and then a week after that it expired (which they also could have told me to be aware of, but didn't). And now I can't apply for the C band license part, despite having committed work to uplink sporting events on C band, which was the entire point of buying this truck. What can I do to fix this???

PS- The previous owner got hit with that same \$700 fine for not renewing the license that didn't transfer, just like I did for my old truck that was sold. Great way to be supporting small businesses here, guys. We struggle to earn a living in the worst economy for live event coverage in years and you just take and take for no good reason, just because you can. And if we don't give, you take even more. 🙄
