This earth station will utilize a 3.8 meter C-band transmit and receive antenna to distribute digital audio program information, as well as some limited data service, to a variety of downlink facilities primarily at radio stations located through out the United States. Domestic C-band (ALSAT) satellites are to be utilized, all are US licensed.
