We need to add 12 antennas to an existing earth station registration that have always existed and in use prior to the FCC deadline registration date of 4/19/18 and should be eligible for the Cband lump sum reimbursement pool or at least interference protection. There were not clear instructions shown by the IBFS system when we initially registered our earth station regarding antennas other than a site based registration process. Individual antennas at the time were not elaborated about in terms of listing each one in order to obtain frequency protection.
