Hi, Eleanor.

I worked at Adelphia (as Director of FCC Technical Compliance) until it was sold to Time Warner Cable and Comcast in July 2006. A couple of earth station registrations were missed for owner change notices, and now they are no longer needed but are still in Adelphia entity names. See below for what Time Warner Cable says about them. Instead of waiting for them to expire years from now, I would like to be proactive and get them taken care of.

Would it be possible for me to surrender E5927 and E8221? There is no one left at Adelphia, they no longer operate anywhere, so no official can be contacted.

E5927 North Olmsted: the site was removed
E8221 Bainbridge: the site was removed
E6900 Enterprise, AL the site is still in place and active as this is a standalone headend.

I talked with John Wilner several years ago about getting these transferred out of Adelphia's name. He said there was no longer anyone that could sign the transfer forms so I put them on the inactive list to let them expire.

Good afternoon, Monique. I don't know if this falls into your "FCC License" responsibilities, but the following TVRO *registrations* are apparently still in an Adelphia entity name:

E5927 - North Olmsted, OH
E8221 - Bainbridge, OH
E6900 - Enterprise, AL

I was doing some unrelated consulting work when I noticed these records in the FCC's database; you may want to look into them to confirm that the operator name needs to be changed. If these are not within your responsibilities, perhaps you could forward this message to the appropriate person.

A little background: I worked for Adelphia for more than three years, up until the systems were sold to Comcast and Time Warner Cable. I was essentially Don Sambol's counterpart, so we worked together to move files over and get the appropriate lists made. (The three TVROs above are on the final Adelphia list, which shows them going to TWC.) In the not-so-distant past, I worked for Windjammer Cable, which acquired many former Adelphia systems from TWC in 2008.
