Liberty Cable Vision of Puerto Rico Ltd. and Liberty Cablevision of Puerto LLC merged on **January 10, 2012**. The combined entity took the name Liberty Cablevision of Puerto LLC.

License E6811 is currently registered to Puerto Rico Cable Acquisition Company LLC as a receive-only earth station. In June 2015, Liberty Cablevision of Puerto LLC's parent, Liberty Global, acquired a 100% interest in the parent of Puerto Rico Cable Acquisition Company LLC. Until July 2015, E6811 was licensed to Puerto Rico Cable Acquisition Company Inc. **In July 2015**, the transaction was consummated and E6811 was assigned from Puerto Rico Cable Acquisition Company Inc. to Puerto Rico Cable Acquisition Company LLC pursuant to the filing of FCC Form 312.
