
Dear Ms. Dortch:

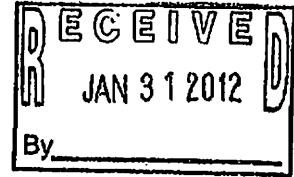


“Article I of the Revised Articles of Incorporation of the Corporation is hereby deleted in full and replaced with the following:


The name of the corporation is **CALVARY OF ALBUQUERQUE, INC.** (hereinafter referred to as the Corporation”).”
