Good afternoon Jae Lim – Hope you are well. I work with Paul Cicelski and was asked to review the renewal application for E970987 and your request for verification of coordinates. You are correct that there is no Earth Station dish at the referended coordinates.

Actually, the error occurred fifteen years ago on a modification application filed in 2006 (File Number SES-MOD-20060224-00301 - attached). The application included a typographic error that specified 38 degrees latitude instead of 39 degrees. The actual coordinates are 39° 58' 32.0" N 83° 3' 34.0" W. Note that the 2006 application had wrong coordinates, but specified the correct street address, 1261 Dublin Road, Columbus, OH. This is the same address as had been specified on the earlier license (File Number SES-LIC-19860626-03121 – attached) and is the address that was specified on the September 2020 ECFS filing for C-Band reimbursement.

Further, at Page 6, Item 27, Purpose of Modification, the application specified

a - authorization to add new emission designator and related service and

i - authorization to add Points of Communication (satellites & amp; countries)

but did not identify f - authorization to relocate fixed station

We respectfully request that the International Bureau process the renewal application and additionally update its records to reflect 39° 58' 32.0" N 83° 3' 34.0" W, coordinates which match the street address, as the actual coordinates for C-Band Earth Station E860987.
