

### **Viasat Inc. Ownership Information**

Viasat, Inc. (“Viasat”) submits this Form 312-R Renewal Application seeking renewal of its earth station Call Sign E050033 (the “License”). Question 8 of the form requires a renewal applicant to identify the most recent application or report containing information regarding the applicant’s organization.

Viasat has provided information regarding its organization and ownership in certain previously filed Commission applications in connection with the License, including a transfer of control application in connection with Viasat’s acquisition of WildBlue,<sup>1</sup> and the *pro forma* assignment of the license to Viasat.<sup>2</sup> While there have not been changes since those applications that would constitute a “transfer of control or other changes in the applicant’s relation to the station, or financial responsibility,” there are fluctuations in the ownership interests reported, and some of the officers and directors have changed over time. Therefore, the following is an update to the ownership and officer/director information that Viasat has filed in previous International Bureau applications pertaining to License.

Viasat is a Delaware corporation and a publicly traded company headquartered at 6155 El Camino Real, Carlsbad, California 92009. As a publicly traded company, the stock of Viasat is widely held. Based on publicly available SEC filings, the following entities and their affiliates beneficially owned 10 percent or more of Viasat’s voting stock:
