The referenced STA was granted with respect to license application file number SES-MOD-20041029-01608. This STA was granted on January 5, 2005, and is effective through March 11, 2005. The underlying modification application has not yet been granted, and Applicant therefore requests that the Bureau renew the referenced STA to permit the continued use of the antenna in question. As discussed in the earlier STA application, grant of this renewal would be in the public interest by permitting the uninterrupted provision of urgently-required service to Telenor's customers.
