The underlying application to FCC has been indirectly delayed due to delays related to FCC software problems over the past several weeks (contact Jerry Ma-FCC). TVU, a non-commercial educational video service of Radio U, WUFM 88.7, will conduct its video fund raiser coincidentally with this move. This broadcaster provides over the air and on-site programs for local schools and community centers presenting anti-drug and service awareness programs in conjunction with youth centered events. This is a semi-annual fundraiser. There is also an existing license E010175 which will be surrendered after the move. A frequency coordination has been successfully conducted and included in the underlying application.
