12. Description

Globalstar USA, LLC ('Globalstar') is applying for Special Temporary Authority to operate four earth station antennas from its proposed gateway location in Sebring, Florida, to communicate with the Globalstar LLC Mobile Satellite Service ('MSS') satellite constellation. The earth station antennas are necessary for Globalstar to meet increased customer demand that cannot adequately be met using the earth stations at Globalstar's existing U.S. gateways, which are already operating at full capacity and which are at too great a distance from the areas of increased customer demand to provide reliable service. Globalstar has filed four separate applications for special temporary authority — one for each antenna at the proposed Sebring, Florida location. Globalstar requests that they be processed simultaneously.
